Explanatory Note

(This does not form part of the notification; but is intended to indicate its general purport).

Section 3 of the Kerala Marine Fishing Regulation Act, 1980, empowers the Government to authorise officers to exercise the powers conferred by and discharge the duties empowered upon the authorised officers under the Act. The Government vide G.O. (Rt) No. 246 / 97 / F & PD dated 12-6-1997 accorded sanction for the establishment of Fisheries Station at Vizhinjam and Kannur with Assistant Director of Fisheries as heads of officers for the effective implementation of the said Act. The said officers are to be notified as authorised officers.

The notification is intended to achieve the above object.
