Notification dated 5th January 2001 Imposing uniform ban on fishing operations in the East Coast of Tamil Nadu

ABSTRACT

FISHERIES – Tamilnadu Fishing Regulation Act, 1983 – Imposing uniform ban on fishing operations in the East Coast of Tamil Nadu for a period of 45 days from 15th April to 29th May (Both days inclusive) every year – Orders issued

ORDER:

In the letter third read above, the Director of Fisheries, Chennai has submitted proposals to the Government to impose total ban on fishing operations in the East Coast of Tamil Nadu starting from Thiruvallur Revenue District to Kanniyakumari town in the East Coast from 15th April to 29th May for 45 days every year with a view to conserving the fishery wealth in the sea as in the case of Andhra Pradesh State where the Government of Andhra Pradesh Prohibited fishing operations in the sea along the entire coast line of Andhra Pradesh State.

- 2) The Government have considered the proposals of the Director of Fisheries in detail and they are convinced of the need to conserve the fishery wealth. The Tamil Nadu Marine Fishing Regulation Act, 1983 (Published in Tamil Nadu Government Gazette vide authority No.106 on 5.3.1983) 5(1) (a) and 5 (2) (b) provide for publication of notification prohibiting fishing operations in a particular area during the particular period for conservation of fishery wealth on a Scientific basis.
- 3) The Government therefore direct that the appended notification shall be published in the next issue of the Tamil Nadu Government Gazette.
- 4) The Director of Stationery and Printing, Chennai is requested to print 250 copies of notification and send to the Director of Fisheries and to the Government.

APPENDIX

NOTIFICAITON

In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 and 9 clause (b) of subsection (2) of section 5 of the Tamil Nadu Marine Fishing Regulation Act, 1983 (Tamil Nadu Act 8 of 1983), the Governor of Tamil Nadu hereby prohibits the fishing by the mechanized fishing boats/trawlers along the entire East Coast of Tamil Nadu starting from the Thiruvallur Revenue District to Kanniyakumari town for a period of 45 days from the 15th April to the 29th May every year (both days inclusive) to conserve the fishery wealth in the sea.

2) This order shall come into force with effect on and from 5.1.2001.
