### MAHARASHTRA MARINE FISHING REGULATION ACT, 1981.

No. Matsyavi,1990/4246/(47)/ADF-14-- In exercise of the powers conferred by subsections (1) and (2) of section 25 of the Maharashtra Marine Fishing Regulation Act, 1981 (Mah. LIV of 1981), and of all other powers enabling it in this behalf, Government of Maharashtra hereby makes following rules to further amend the Maharashtra Marine Fishing Regulation Rules,1982 the same having been previously published as required by sub-section (3) of the said section 25, namely:-

#### **RULES**

- 1. These rules may be called the Maharashtra Marine Fishing Regulation (Amendment) Rules, 2001.
- 2. In Rule 4 of the Maharashtra Marine Fishing Regulation Rule, 1982 (hereinafter referred to as "the principal rules"), -
  - (1) in sub-rule (1), in the column under the heading "Fees",--
    - (a) against entry (i), for the words "One hundred rupees", the words "Five hundred rupees" shall be substituted;
    - (b) against entry (ii), for the words "Fifty rupees", the words "Two hundred rupees" shall be substituted;
    - (c) against entry (iii), for the words "Twenty rupees", the words "One hundred rupees" shall be substituted; and
    - (d) against entry (iv), for the words "Ten rupees", the words "Fifty rupees" shall be substituted.
  - (2) after the sub-rule (3), the following sub-rule shall be added, namely :-
    "(4) the fees for the grant of a duplicate licence under section 6 of the Act shall be rupees two hundred".
- 3. In Rule 9 of the principal rules, for the words, "rupees five", the words "rupees two hundred" shall be substituted.
- 4. After Rule 11 of the principal rules, the following rule shall be inserted, namely :- "11A, Fees for grant of permission for operating fishing vessels form a port other than the one specified in the registration certificate. The application for grant of permission for operating fishing vessels from a part other than the one specified in the registration certificate under sub-section (3) of section 10 of the Act shall be accompanied by a fee of rupees three hundred."

5. After Rule 14 of the principal rules, the following rule shall be inserted, namely:"15. Fees for filing an appeal under sub-section (3) of section 18. Fees for filing of
an appeal under sub-section (3) of section 18 of the Act, shall be rupees one
thousand".
