## NOTIFICATION

In exercise of the powers conferred under sub-section (1) of section 24 read with sub-section (1) and (2) of section 18 of the Andhra Pradesh Marine Fishing (Regulation) Act, (Act No.9 of 1995), the Government of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Marine Fishing (Regulation) Rules, 1995 notification issued in G.O.Ms.No.26, Animal Husbandry, Dairy Development & Fisheries (Fish. I) Department dated 13<sup>th</sup> March 1996, as amended from time to time.

## AMENDMENT

To sub rule (10) of rule 12 of the said rules; the following expression shall be added at the end namely: -

In places where there is no Government agency to issue seaworthiness certificate, the Commissioner of Fisheries may authorize such private agencies who are capable of issue of seaworthiness' certificate to such category of fishing vessels.
