

NOTIFICATION

New Delhi, the 5th February, 2019

S.O. 762(E).—In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Government of India (Allocation of Business) Rules, 1961, namely:-

1. (1) These rules may be called the Government of India (Allocation of Business) Three Hundred and Forty Eighth Amendment Rules, 2019.
- (2) They shall come into force at once.
2. In the Government of India (Allocation of Business) Rules, 1961,-
 - (1) in THE FIRST SCHEDULE, under the heading "1. Ministry of Agriculture and Farmers Welfare (Krishi Evam Kisan Kalyan Mantralaya)",-
 - (a) for the sub-heading "(iii) Department of Animal Husbandry, Dairying and Fisheries (Pashupalan, Dairy aur Matsyapalan Vibhag)", the following sub-heading shall be substituted, namely:-

"(iii) Department of Animal Husbandry and Dairying (Pashupalan aur Dairy Vibhag)";
 - (b) after the sub-heading "(iii) Department of Animal Husbandry and Dairying (Pashupalan aur Dairy Vibhag)" as so substituted, the following sub-heading shall be inserted, namely:-

"(iv) Department of Fisheries (Matsyapalan Vibhag).";
 - (2) in THE SECOND SCHEDULE, under the heading "MINISTRY OF AGRICULTURE AND FARMERS WELFARE (KRISHI EVAM KISAN KALYAN MANTRALAYA)", -
 - (a) for the sub-heading "C. DEPARTMENT OF ANIMAL HUSBANDRY, DAIRYING AND FISHERIES (PASHUPALAN, DAIRY AUR MATSYAPALAN VIBHAG)", the following sub-heading shall be substituted, namely:-

“C. DEPARTMENT OF ANIMAL HUSBANDRY AND DAIRYING (PASHUPALAN AUR DAIRY VIBHAG)”;

- (b) in PART I under the sub-heading (C) as so substituted-
- (i) in entry 1, for the words “Livestock, fish and birds feed and dairy, poultry and fish products”, the words “Livestock and birds feed and dairy and poultry products” shall be substituted;
- (ii) after entry 1, the following entries shall be inserted, namely:—
- “1A. Promotion and Development of Livestock, Dairy and Poultry and its associated activities, including infrastructure development, Marketing, Exports and institutional arrangements etc.
- 1B. Welfare of persons engaged in activities relating to livestock, Dairy and Poultry.”;
- (iii) in entry 2, for the words “livestock, poultry and fisheries development”, the words “livestock and poultry development” shall be substituted;
- (iv) the entries 7 and 8 shall be omitted;
- (c) in PART II, in entry 10, for the words “or infectious or contagious diseases or pests affecting animals, fish and birds”, the words “of infectious or contagious diseases or pests affecting animals and birds” shall be substituted;
- (d) in PART III,-
- (i) in entry 13, for the words “animals, fish and birds”, the words “animals and birds” shall be substituted;
- (ii) in entry 15, for the words “livestock, fish and birds”, the words “livestock and birds” shall be substituted.
- (e) after the sub-heading “C. DEPARTMENT OF ANIMAL HUSBANDRY AND DAIRYING (PASHUPALAN AUR DAIRY VIBHAG)”, and the entries relating thereto, the following sub-heading and entries shall be inserted, namely:—

“D. DEPARTMENT OF FISHERIES (MATSYAPALAN VIBHAG)

PART I

The following subjects which fall within List I of the Seventh Schedule to the Constitution of India:

1. Industries, the control of which by the Union is declared by Parliament by law to be expedient in Public interest as far as these relate to Development of fish feed and fish products with the limitation that in regard to the development of industries, the functions of the Department of Fisheries do not go further than the formulation of the demand and fixation of targets.
2. Promotion and development of Fishing and Fisheries (inland, marine and beyond territorial waters) and its associated activities, including infrastructure development, Marketing, Exports, and institutional arrangements etc.
3. Welfare of Fishermen and other Fisher-folk and strengthening of their livelihoods.
4. Liaison and cooperation with international organizations in matters relating to fisheries development.
5. Fisheries Statistics.
6. Matters relating to loss of fish stock due to natural calamities.
7. Regulation of fish stock importation, Quarantine and Certification.
8. Fishery Survey of India, Mumbai.

PART II

The following subjects which fall within List III of the Seventh Schedule to the Constitution of India (as regards legislation only):

9. Prevention of the extension from one State to another of infectious or contagious diseases or pests affecting fish.
10. Pattern of financial assistance to various State Undertakings, Fisheries Development Schemes through State agencies/Co-operative Unions.

PART III

For the Union Territories the subjects mentioned in Parts I and II above, so far as they exist in regard to these territories and, in addition, to the following subjects which fall within List II of the Seventh Schedule to the Constitution of India:

11. Preservation, protection and improvement of fish stocks and prevention of diseases thereof, Veterinary training and practice.
12. Insurance of fish stock.”.
